# **Beware of Phishing!**

#### **How to Avoid Email Scammers**

Scammers use email or text messages to trick you into giving them your personal information. They may try to steal your passwords, account numbers, or Social Security numbers. If they get that information, they could gain access to your email, bank, or other accounts. Scammers launch thousands of phishing attacks like these every day — and they're often successful. Scammers often update their tactics, but there are some signs that will help you recognize a phishing email or text message.

What is phishing? When scammers (phishing scammers) use ghost/fraudulent emails, texts, phone calls, and remote access attacks to get the unknowing public to share personal information including account numbers, login information, Social Security Numbers, financial information, gain access to your computer or network. They use a number of tools to steal money, identities, or both.

Here are other tips to help safeguard against phishing scammers:

- Be cautious about opening attachments or clicking on links in emails. Many times the fraudulent emails will look like they are from someone you know. Such links can contain malware or ransomware that can lock you out of your computer or worse. A remote attack targets an individual computer or network as the cybercriminal exploits weaknesses in security settings to access the devices. Another line of attack uses malware to download malicious code that gives criminals access to the network. Especially vulnerable are wireless networks, including mobile phones, modems, and router devices, printers, fax machines and televisions that retain their factory-issued password settings. Sometimes, these devices have no protection at all.
- If a person or organization emails you a link, search online for the Website or other information contained in the email to verify it is not a scam.
- Do not respond to emails requesting personal or financial information without picking up the telephone and verifying with the person or entity making the request.
- Keep your security up to date and run periodic deep scans to search for viruses or malware.
- Turn on two-factor authentication for accounts that support it and strengthen passwords.
- Always check the email address!!! Typically spammers will use a familiar name, but when you look at the email it has nothing to do with that person. That is an easy way to know it is spam.

Report phishing:

Report all unsolicited email - including the full email headers - claiming to be from the IRS or an IRS-related function to <a href="mailto:phishing@irs.gov">phishing@irs.gov</a>. If you've experienced any monetary losses due to an IRS-related incident, please report it to the <a href="mailto:Treasury Inspector General for Tax Administration (TIGTA)">Treasury Inspector General for Tax Administration (TIGTA)</a>, the <a href="mailto:Federal Trade Commission">Federal Trade Commission</a>, and the <a href="mailto:Internet Crime Complaint Center (IC3)</a>. People can also forward the email to your internet service provider's abuse department.
 NOTE: You can get help with most tax issues <a href="mailto:online or by phone">online or by phone</a>.

#### What to do if you receive a suspicious IRS-related email (updated Jan. 19, 2024)

If you receive an **email** claiming to be from the IRS that contains a request for personal information, taxes associated with a large investment, inheritance or lottery.

- 1. Don't reply.
- 2. Don't open any attachments. They can contain malicious code that may infect your computer or mobile phone.
- 3. Don't click on any links. Visit our <u>identity protection</u> page if you clicked on links in a suspicious email or website and entered confidential information.
- 4. Send the <u>full email headers</u> or forward the email as-is to <u>phishing@irs.gov</u>. Don't forward screenshots or scanned images of emails because this removes valuable information.
- 5. Delete the original email.

#### How do I verify contact from the IRS?

Go to IRS.gov and search on the letter, notice, or form number. Please be aware fraudsters often modify legitimate IRS letters and forms. You can also find information at <u>Understanding your notice or letter</u> or by searching <u>forms and instructions</u>. For additional information please see <u>How to know it's really the IRS calling or knocking on your door</u>.

If it is legitimate, you'll find instructions on how to respond. If the completion of a form is required and it's provided by a

questionable contact, you should verify the form is identical to the same form on IRS.gov by searching <u>forms and instructions</u>. If you don't find information on our website or the instructions are different from what you were told to do in the letter, notice or form, please use the appropriate <u>online resources</u>.

Once you have determined that it is not legitimate, report the incident to <u>TIGTA</u> and <u>phishing@irs.gov</u>.

#### What if I receive a phishing email that is not IRS or tax-related? (updated Jan. 19, 2024)

Phishing emails that are not IRS, Treasury and tax-related should **not** be sent to phishing@irs.gov. If you receive a suspicious phishing email not claiming to be from the IRS, forward the email as-is to <a href="mailto:reportphishing@antiphishing.org">reportphishing@antiphishing.org</a>, your internet service provider's abuse department, and to the <a href="mailto:Federal Trade Commission">Federal Trade Commission</a>. If you receive an **email** you suspect **contains malicious code** or a malicious attachment and you **HAVE** clicked on the link or downloaded the attachment, visit <a href="mailto:OnGuardOnline.gov">OnGuardOnline.gov</a> to learn what to do if you suspect you have malware on your computer. If you receive an **email** you suspect **contains malicious code** or a malicious attachment and you **HAVE NOT** clicked on the link or downloaded the attachment, forward the email to your internet service provider's abuse department.

Treasury and IRS announce final regulations on how to report and pay the corporate stock repurchase excise tax

IR-2024-179, June 28, 2024 — The Department of the Treasury and the Internal Revenue Service today issued final regulations that provide taxpayers and tax professionals with guidance on how to report and pay the 1 percent excise tax owed on corporate stock repurchases.

<u>Treasury, IRS issue final regulations requiring broker reporting of sales and exchanges of digital assets that are subject to tax</u> under current law, additional guidance to provide penalty relief, address information reporting and other technical issues

IR-2024-178, June 28, 2024 — The U.S. Department of the Treasury and the Internal Revenue Service today issued final regulations requiring custodial brokers to report sales and exchanges of digital assets, including cryptocurrency.

IRS: Marijuana remains a Schedule I controlled substance; Internal Revenue Code Section 280E still applies

IR-2024-177, June 28, 2024 — Until a final federal rule is published, the Internal Revenue Service today reminded taxpayers that marijuana remains a Schedule I controlled substance and is subject to the limitations of Internal Revenue Code.

IRS provides tax relief for taxpayers impacted by severe storms, straight-line winds, tornadoes and flooding in Mississippi; various deadlines postponed to Nov. 1, 2024

IR-2024-176, June 27, 2024 — The Internal Revenue Service announced today tax relief for individuals and businesses in Mississippi that were affected by severe storms, straight-line winds, tornadoes and flooding that began on April 8, 2024.

Electronic Tax Administration Advisory Committee 2024 Annual Report includes recommendations to Congress and IRS

IR-2024-175, June 26, 2024 — The Internal Revenue Service Electronic Tax Administration Advisory Committee (ETAAC) released its 2024 annual report today with a total of 12 recommendations – three to Congress and nine to the IRS.

IRS sending settlement offer letters in July to certain taxpayers who participated in Syndicated Conservation Easement transactions

IR-2024-174, June 26, 2024 — The Internal Revenue Service today announced the mailing of a time-limited settlement offer for certain taxpayers who participated in Syndicated Conservation Easements (SCE) and substantially similar transactions that are under audit in the IRS's Large Business & International and Small Business and Self-Employed divisions.

National Taxpayer Advocate issues mid-year report to Congress; highlights filing season challenges and focuses on strategic priorities

IR-2024-173, June 26, 2024 — National Taxpayer Advocate Erin M. Collins today released her statutorily mandated mid-year report to Congress.

IRS statement as part of the resolution of Kenneth C. Griffin v. IRS, Case No. 22-cv-24023 (S.D. Fla.)

IR-2024-172, June 25, 2024 — The Internal Revenue Service sincerely apologizes to Mr. Kenneth Griffin and the thousands of other Americans whose personal information was leaked to the press.

IRS releases revised draft Form 6765, Credit for Increasing Research Activities, following public comment

IR-2024-171, June 21, 2024 — The Internal Revenue Service today announced the release of draft Form 6765, Credit for Increasing Research Activities, also known as the Research Credit.

Retirement plan distributions: IRS provides guidance on certain exceptions from 10% additional tax for emergency personal or family expenses and for survivors of domestic abuse

IR-2024-170, June 20, 2024 — The Internal Revenue Service today issued Notice 2024-55, which provides guidance on exceptions to the additional tax when taking early permissible retirement plan distributions for emergency personal expenses and for victims of domestic abuse.

IRS enters next stage of Employee Retention Credit work; review indicates vast majority show risk of being improper

IR-2024-169, June 20, 2024 — Following a detailed review to protect taxpayers and small businesses, the Internal Revenue Service today announced plans to deny tens of thousands of improper high-risk Employee Retention Credit claims while starting a new round of processing lower-risk claims to help eligible taxpayers.

<u>Treasury, IRS release guidance on the prevailing wage and apprenticeship requirements for increased credit and deduction</u> amounts under the Inflation Reduction Act

IR-2024-168, June 18, 2024 — The Department of the Treasury and the Internal Revenue Service issued final regulations today on the prevailing wage and apprenticeship (PWA) requirements related to increased credit or deduction amounts for certain clean energy incentives, enacted as a part of the Inflation Reduction Act (IRA).

<u>Treasury, IRS issue frequently asked questions regarding educational assistance programs</u>

IR-2024-167, June 17, 2024 — The Internal Revenue Service today issued frequently asked questions related to educational assistance programs.

IRS announces new steps to combat abusive use of partnerships; agency's focus intensifies as new guidance closes loopholes worth tens of billions

IR-2024-166, June 17, 2024 — As part of ongoing efforts to focus more attention on high-income compliance issues, the Internal Revenue Service announced today a new series of steps to combat abusive partnership transactions that allow wealthy taxpayers to avoid paying what they owe.

IRS updated careers website aims to better connect with job seekers; part of larger agency recruiting efforts to serve taxpayers, the nation

IR-2024-165, June 13, 2024 — The Internal Revenue Service today announced the updated IRS Careers website is live and ready to connect job seekers with IRS opportunities.

IRS warns against scams targeting seniors; joins other federal agencies to recognize special awareness day

IR-2024-164, June 12, 2024 — As part of continuing efforts to protect the senior community, the Internal Revenue Service today issued a warning about the rising threat of impersonation scams.

<u>2024 IRS Nationwide Tax Forum: Educational seminars, special events announced focusing on tax security, scams, practice management and beneficial ownership information</u>

IR-2024-163, June 12, 2024 — The Internal Revenue Service today announced the continuing education agenda for the 2024 Nationwide Tax Forum featuring 45 seminars on a wide array of topics that will help tax professionals serve their clients.

### IRS has options to help people who missed the April filing deadline

IR-2024-162, June 10, 2024 — The Internal Revenue Service today highlighted a number of options available to help taxpayers who missed the April deadline to file their 2023 federal income tax return.

#### IRS reminder: June 17 estimated tax payment deadline fast approaching

IR-2024-161, June 10, 2024 — The Internal Revenue Service today reminded taxpayers whose income is not subject to withholding that the second quarter estimated tax payment deadline is June 17.

#### IRS: West Virginia storm victims qualify for tax relief; various deadlines postponed to Nov. 1

IR-2024-160, June 7, 2024 — The Internal Revenue Service announced today tax relief for individuals and businesses in parts of West Virginia affected by severe storms, straight-line winds, tornadoes, flooding, landslides and mudslides that began on April 2, 2024.

#### IRS: Kentucky storm victims qualify for tax relief; various deadlines postponed to Nov. 1

IR-2024-159, June 7, 2024 — The Internal Revenue Service announced today tax relief for individuals and businesses in parts of Kentucky affected by severe storms, straight-line winds, tornadoes, landslides and mudslides that began on April 2, 2024.

<u>Treasury, IRS update procedures for qualified manufacturers, dealers and sellers of certain qualified clean vehicles under the Inflation Reduction Act</u>

IR-2024-158, June 7, 2024 — The Department of the Treasury and Internal Revenue Service issued Revenue Procedure 2024-26 today for the submission of information by qualified manufacturers of new clean vehicles and dealers and sellers of new clean vehicles and previously-owned clean vehicles.

#### <u>Treasury, IRS release guidance for the Energy Community Bonus Credit under the Inflation Reduction Act</u>

IR-2024-157, June 7, 2024 — The Department of the Treasury and Internal Revenue Service today issued Notice 2024-48 that publishes information taxpayers may use to determine whether they meet certain requirements under the Statistical Area Category or the Coal Closure Category in Notice 2023-29 for purposes of qualifying for the Energy Community Bonus Credit.

IRS: Many payments to individuals affected by East Palestine train disaster are tax-free; new guidance could help those in Ohio, Pennsylvania, West Virginia

IR-2024-156, June 5, 2024 — The Internal Revenue Service announced today that in many cases payments received by individuals affected by last year's train derailment in East Palestine, Ohio, are not taxable.

#### Document Upload Tool reaches key milestone; 1 million submissions received

IR-2024-155, June 5, 2024 — The Internal Revenue Service announced today reaching another key milestone in the agency's transformation work with the Document Upload Tool accepting its one millionth taxpayer submission.
