On top of all of our scheduled networking opportunities and receptions, many chapters host get-togethers, and you may even run into some of the speakers at the black-jack table on your way through the casino.


This is truly a special event that is not to be missed.

### [IRS releases fiscal year 2024 Data Book describing agency's activities](#)

IR-2025-63, May 29, 2025 – The Internal Revenue Service today issued its annual Data Book detailing the agency's activities during fiscal year 2024 (Oct. 1, 2023 – Sept. 30, 2024).
