TAX CUTS & JOBS ACT OF 2017 – TIPS, STRATEGIES & TRICKS

On December 22, 2017, the President signed into law H.R.1, the Tax Cuts and Jobs Act (TCJA). TCJA revises numerous provisions in the Tax Code, with one of the more significant changes being the introduction of the 20% deduction for domestic qualified business income, also known as the Section 199A deduction.

- How to manage your clients' assets in this new (temporary) environment
