## **Beware of Phishing!**

#### **How to Avoid Email or Text Scammers**

Scammers use email or text messages to trick you into giving them your personal information. They may try to steal your passwords, account numbers, or Social Security numbers. If they get that information, they could gain access to your email, bank, or other accounts. Scammers launch thousands of phishing attacks like these every day — and they're often successful. Scammers often update their tactics, but there are some signs that will help you recognize a phishing email or text message.

What is phishing? When scammers (phishing scammers) use ghost/fraudulent emails, texts, phone calls, and remote access attacks to get the unknowing public to share personal information including account numbers, login information, Social Security Numbers, financial information, gain access to your computer or network. They use a number of tools to steal money, identities, or both.

Here are other tips to help safeguard against phishing scammers:

- Be cautious about opening attachments or clicking on links in emails. Many times the fraudulent emails will look like they are from someone you know. Such links can contain malware or ransomware that can lock you out of your computer or worse. A remote attack targets an individual computer or network as the cybercriminal exploits weaknesses in security settings to access the devices. Another line of attack uses malware to download malicious code that gives criminals access to the network. Especially vulnerable are wireless networks, including mobile phones, modems, and router devices, printers, fax machines and televisions that retain their factory-issued password settings. Sometimes, these devices have no protection at all.
- If a person or organization emails you a link, search online for the Website or other information contained in the email to verify it is not a scam.
- Do not respond to emails requesting personal or financial information without picking up the telephone and verifying with the person or entity making the request.
- Do not respond to emails and text requesting you to purchase gift cards without picking up the telephone and verifying with the person or entity making the request.
- Keep your security up to date and run periodic deep scans to search for viruses or malware.
- Turn on two-factor authentication for accounts that support it and strengthen passwords.
- Always check the email address!!! Typically spammers will use a familiar name, but when you look at the email it has nothing to do with that person. That is an easy way to know it is spam.

#### What to do if you receive a suspicious email or text

Unfortunately, these scams are a fact of life in our digital age, and we must be vigilant before responding. If you receive an suspiscious email or text, make sure to always check the email address of the sender. If the email address is unfamiliar or doesn't match with contact information familiar to you, that is a good indication that it is a scam.

Ask yourself if the request and urgency makes sense. Have you spoken with the person by phone? If not, proceed with caution

- 1. Don't reply.
- 2. Don't open any attachments. They can contain malicious code that may infect your computer or mobile phone.
- 3. Don't click on any links. Visit our <u>identity protection</u> page if you clicked on links in a suspicious email or website and entered confidential information.
- 4. Send the full email headers or forward the email as-is to <a href="mailto:phishing@irs.gov">phishing@irs.gov</a> if the suspicious phishing email is claiming to be from the IRS. Phishing emails that are not IRS related to your internet service provider's abuse department. Don't forward screenshots or scanned images of emails because this removes valuable information.
- 5. Delete the original email.

What if I receive a phishing email that is not IRS or tax-related? (updated Jan. 19, 2024)

Phishing emails that are not IRS, Treasury and tax-related should **not** be sent to phishing@irs.gov.

If you receive a suspicious phishing email not claiming to be from the IRS, forward the email as-is to <a href="mailto:reportphishing@antiphishing.org">reportphishing@antiphishing.org</a>, your internet service provider's abuse department, and to the <a href="mailto:Federal Trade Commission">Federal Trade Commission</a>.

If you receive an **email** you suspect **contains malicious code** or a malicious attachment and you **HAVE** clicked on the link or downloaded the attachment, visit <a href="mailto:OnGuardOnline.gov">OnGuardOnline.gov</a> to learn what to do if you suspect you have malware on your computer.

If you receive an **email** you suspect **contains malicious code** or a malicious attachment and you **HAVE NOT** clicked on the link or downloaded the attachment, forward the email to your internet service provider's abuse department.

## IRS provides transition relief for third-party settlement organizations; Form 1099-K threshold is \$5,000 for calendar year 2024

IR-2024-299, Nov. 26, 2024 — The Internal Revenue Service today issued Notice 2024-85 providing transition relief for third-party settlement organizations (TPSOs), also known as payment apps and online marketplaces, regarding transactions during calendar years 2024 and 2025.

## Save for retirement now, get a tax credit later: Saver's Credit can help low- and moderate-income taxpayers save more in 2025

IR-2024-298, Nov. 25, 2024 —The Internal Revenue Service today reminded low- and moderate-income taxpayers that they can save for retirement now and possibly earn a tax credit in 2025 and future years.

#### IRS encourages taxpayers to prepare for 2025 filing season with online tools and key reminders

IR-2024-297, Nov. 22, 2024 — As the nation's tax season approaches, the Internal Revenue Service is reminding people of simple steps they can take now to prepare to file their 2024 federal tax returns.

## IRS urges businesses to act by Nov. 22 to resolve improper Employee Retention Credit claims through Voluntary Disclosure Program; third-party payer deadline newly extended to Dec. 31

IR-2024-296, Nov. 21, 2024 — With a Nov. 22 deadline rapidly approaching for the second Voluntary Disclosure Program, the Internal Revenue Service urgently recommends that businesses review Employee Retention Credit guidelines and resolve incorrect claims soon to avoid future issues.

#### IRS, Security Summit partners announce 9th annual National Tax Security Awareness Week starting Dec. 2

IR-2024-295, Nov. 21, 2024 — The Internal Revenue Service, working with the Security Summit partners, today announced a special awareness week focusing on taxpayers and tax professionals to protect sensitive financial information from identity thieves and tax scams as the holidays and the 2025 tax season approach.

IRS takes steps to help prevent refund delays by accepting duplicate dependent returns with an IP PIN for 2025 filing season; taxpayers encouraged to sign up soon for IP PIN, Online Account

IR-2024-294, Nov. 21, 2024 — The Internal Revenue Service is making it easier for taxpayers to protect their information and avoid refund delays by accepting certain e-filed tax returns that claim dependents who have already been claimed on another taxpayer's return.

#### **IRS Advisory Council issues 2024 annual report**

IR-2024-293, Nov. 20, 2024 — The Internal Revenue Service Advisory Council (IRSAC) today issued its annual public report, including recommendations to the IRS on new and continuing issues in tax administration.

#### <u>Treasury, IRS finalize more partnership clean energy regulations and propose related administrative requirements</u>

IR-2024-292, Nov. 19, 2024 — The Department of the Treasury and the Internal Revenue Service released final regulations that will help certain entities that co-own clean energy projects access clean energy tax credits through elective pay (also commonly referred to as direct pay).

#### IRS: International Fraud Awareness Week highlights how to report fraud; taxpayer protection against scams, schemes

IR-2024-291, Nov. 18, 2024 — As part of International Fraud Awareness Week, the Internal Revenue Service reminds taxpayers how to report tax-related fraud in their community to protect personal and financial information from scam artists and tax schemes.

#### **Interest rates decrease for the first quarter of 2025**

IR-2024-290, Nov. 18, 2024 — The Internal Revenue Service today announced that interest rates will decrease for the calendar quarter beginning Jan. 1, 2025.

#### Give more, tax-free: Eligible IRA owners can donate up to \$105,000 to charity in 2024

IR-2024-289, Nov. 14, 2024 — The Internal Revenue Service reminds individual retirement arrangement (IRA) owners age 70½ and older that they can make up to \$105,000 in tax-free charitable donations during 2024 through qualified charitable distributions. That's up from \$100,000 in past years.

Many businesses must report beneficial ownership information to Treasury by Jan. 1; free webinar can help

IR-2024-288, Nov. 12, 2024 — The Internal Revenue Service will sponsor a free one-hour webinar designed to help the many businesses that must report their beneficial ownership information to the Treasury Department's Financial Crimes Enforcement Network.

#### IRS: Healthcare FSA reminder: Employees can contribute up to \$3,300 in 2025; must elect every year

IR-2024-287, Nov. 7, 2024 — The Internal Revenue Service reminds taxpayers that during open enrollment season for flexible spending arrangements (FSAs) they may be eligible to use tax-free dollars to pay medical expenses not covered by other health plans.

#### IRS publishes 2024 Financial Report; resolves longstanding significant deficiency

IR-2024-286, Nov. 7, 2024 — The Internal Revenue Service today released financial information and highlighted selected accomplishments and challenges in its fiscal year 2024 Financial Report.

#### 401(k) limit increases to \$23,500 for 2025, IRA limit remains \$7,000

IR-2024-285, Nov. 1, 2024 — The Internal Revenue Service announced today that the amount individuals can contribute to their 401(k) plans in 2025 has increased to \$23,500, up from \$23,000 for 2024.
