Topic: Business Entities - Updated for Tax Reform

This presentation is intended to help familiarize tax preparers with the various characteristics and tax attributes of different business entity organizational structures. Qualifying members, partners and shareholders as well as Social Security Tax considerations, health insurance and officer payroll considerations vary from entity to entity. Different basis, at risk, and passive activity loss rules also apply to different entities. We will also review specific changes in the TCJA of 2017 for impact on different business entities.
